WHAT IS THE SBA RESTAURANT REVITALIZATION FUND?

Delivers emergency assistance for eligible restaurants, bars, food trucks, caterers, snack bars, inns & other qualifying businesses impacted by COVID-19.

Provides restaurants with funding equal to their pandemic-related revenue loss

funding up to

\$10 million
per business

no more than

\$5 million
per physical location

Does not require repayment as long as the funds are used for eligible costs no later than March 11, 2023.

Allows spending on payroll, mortgage, rent, utilities, food & beverage, maintenance, outdoor seating, supplies, PPE, etc.

APPLICATION PROCESS AND PRIORITY GROUPS

Accepts applications from all eligible applicants on 05/03, but will only process for priority group applications for first 21 days:

Days 1 - 21

Applications processed and funded for priority group including small businesses owned by women, veterans, or socially/economically disadvantaged individuals

Days 21 Fund Exhaustion

Applications accepted for all eligible applicants and processed in the order in which they are approved by SBA
